Please note: The Judge cannot discuss the merits of a pending judicial proceeding prior to trial. If you **DO NOT** respond to the charge(s) BY THE ALLOWED TIME 15 DAYS FROM DATE OF CITATION an additional charge may be filed against you for violating promise to appear. The Department of Public Safety will deny renewal of your driver's license and warrants may be issued for your arrest. A juvenile who fails to appear by the time and date on the citation may have his/her license suspended as required by law. Juveniles 16 and under must contact the court with a parent or guardian.

Some violations can be dismissed when proof is submitted to the court on or before appearance date, with a dismissal fee

OPTION 3. REQUEST FOR DEFERRED DISPOSITION

Eligibility Requirements for Deferred Disposition: You must request Deferred Disposition BY THE 15TH DAY OF YOUR CITATION ISSUED DATE. You will be put on a probationary period for minimum of 90 days and up to 120 days.

If you are under the age of 25, you are required by law to complete a driving safety course approved under Chapter 1001, Education Code. You must pay the amount of your fine plus an additional \$50.00 administrative fee made payable to Alma Municipal Court. **YOU ARE NOT ELIGIBLE FOR DEFERRED DISPOSITION IF YOU: HOLD A CDL, ARE 25 MILES OVER THE POSTED SPEED LIMIT, OR SPEEDING IN A SCHOOL OR WORK ZONE.**

OPTION 4. REQUEST FOR DRIVING SAFETY COURSE

A driving safety course may dismiss one moving violation per year. If you have multiple violations, you may also request deferred disposition. **Eligibility requirements for driving safety:** You must be able to answer true to the statements below to be eligible. Circle T for true or F for false to each statement.

- T | F** I possess a TEXAS driver's license and have enclosed a copy.
- T | F** I have NOT taken a Driving Safety Course in the past 12 month nor am I presently enrolled in a safety course to have a traffic citation dismissed.
- T | F** I have enclosed a copy of my personal auto Insurance.
- T | F** I have enclosed a MONEY ORDER in the amount of \$144.00 made payable to Alma Municipal Court.

You are required to pay the fine of \$144.00 instead of the original fine amount and have the plea agreement notarized. Once above requirements are met, you may mail this request or submit in person at the court with the required documents listed above. Request must be received by or before your court appearance date on your citation. You will receive approval letter with further instructions via mail (if not submitted in person). **YOU ARE NOT ELIGIBLE FOR DRIVING SAFETY COURSE IF YOU: HOLD A CDL, ARE 24 MILES OVER THE POSTED SPEED LIMIT OR SPEEDING IN A SCHOOL OR WORK ZONE.**
